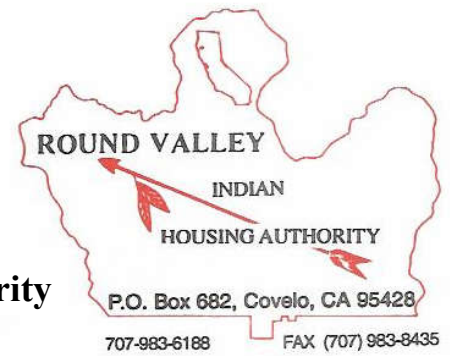

The Round Valley Indian Housing Authority (“RVIHA”) is requesting price quotes from experienced individuals or firms that provide **Information Technology Management Services**. The successful company will work with the RVIHA to provide Managed IT services that include, but are not limited to:

Network setup and maintenance; provide network security by identifying, evaluating and responding to potential threats; secure data storage by providing a platform or service to store data; maintain telephone & VoIP service systems; repair and maintain computer hardware, motherboards and graphics cards, and provide software support by maintaining and monitoring software products that run databases, spreadsheets and/or multimedia; maintain database to secure data to include customer and employee information, sales and finances, and to organize that data to ensure compliance, security and performance of data-driven applications. Provide and maintain a cloud platform or storage option for system backups or additional storage so that users don’t have to keep everything on their main devices. This includes, but is not limited to, any type of IT service that is delivered over the internet or a dedicated cloud network. Maintain web page. Provide on demand IT services as necessary.

Eligible Price quotes should have a track record of successful projects; experience working within tribal government entities is preferred. The individual or firm submitting the price quote is expected to provide a proposed cost and a fee schedule. These requests are not restricted to Indian firms; however, preference will be given to Indian owned enterprises. Any price quote claiming Indian Preference must submit a Qualification statement.

Price quotes received after the date specified shall be considered unresponsive.

The Round Valley Housing Authority reserves the right to accept or reject any or all price quotes and to waive any informality in the quotes received, consistent with the regulations if it is in the best interest of the Round Valley Housing Authority.

The following nondiscrimination requirements are applicable: The Age Discrimination Act of 1975 (42 U.S.C. 6101-6107), Section 504 of the Rehabilitation Act of 1973 (2 U.S.C. 794). The Indian Civilian Rights Act (Title II of the Civil Rights Act of 1968), and Indian Preference Title 25, U.S. Code Sections 472 and 473. Application of Federal Executive Order 11246 (Equal Employment Opportunity), Section 7 (b) of the Indian Self Determination and Education Assistance Act (25) U.S.C. 450e (b) will be enforced.
